- 3. Discussion of Application for Vacation of Public Right of Way: West 12th Street between Hoover Street and 15 ft. Alley located at 145 ft east of Arapahoe St.** – The committee members will discuss request for vacation of public space. The proposed vacation is to perpetualize an existing street closure at the intersection of Hoover St. by connecting the church-owned properties on both side of 12th St. Possible committee action regarding whether to request this applicant to make a presentation to the committee.
- 4. Discussion of Project at 1117-1131 S Elden Ave. 90006** – The committee members will discuss applicant' request to legalize two one-bedroom dwelling units, allowing 21st and 22nd unit within an existing 20-unit apartment building with 39 parking spaces. A Zoning Administrator's Adjustment to the yard regulations is requested pursuant to LAMC Section 12.28-A, to provide relief from L.A.M.C. Section 12-21-G2 to allow a 200-sq ft reduction of open space in a 22-unit apartment building. Possible committee action regarding whether to request this applicant to make a presentation to committee.
