Section 12.28-a, to provide relief from LAMC Section 12.21-G2, allowing a 200-sq ft reduction of open space in a 22-unit apartment building (100-sq. ft per unit from the proposed two additional one-bedroom units) with 39 parking spaces. Possible committee action to approve Zoning Administrator’s Adjustment.
